Boating safety laws reviewed

Here are a few boating safety tips. It is state law that you have a Coast Guard approved Personal Flotation Device type 1, 2 or 3 on board for each person on board your boat. If the


boat is less than 16 feet a type 4 PFD (cushion) is adequate for each person. If the boat is 16 feet or over you must have a type 1, 2, or 3 for each person plus a type 4. The PFD must be readily accessible. That doesn't mean in a locker

or plastic bag it came in. It must be out and available. If you are towing somebody you must also have a PFD on board for that person. A ski belt does NOT qualify as an approved PFD.

A new law this year states that ALL children under age 6 must wear an approved PFD at all times while in an

open area of a boat. This includes the deck area of a pontoon boat.

A reminder for the younger boaters. Children between 12 and 16 must have a State Boater Safety Certificate if they wish to operate a motorboat six horsepower or greater by themselves.

This includes Personal Water Craft (jet skis). This certificate must be in their possession while operating the motorboat.

Remember, these are

ticketable offenses. Last year the Ogemaw Sheriff Department checked many boats one day and sent several to shore to obtain the proper equipment. They or the DNR could have issued a ticket.


Dust control

The first application of calcium chloride was applied to the gravel roads around the lake. Normally the county would not spray our roads. Through a special contract the association is paying the county \$272 for an application to help keep the dust down. There should be one or two more applications this summer depending on need.
